

AN ORDINANCE OF THE CITY OF EAGLE LAKE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE ELECTION HELD ON MAY 7, 2022, FOR THE MAYOR AND TWO ALDERMEN.
