

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for December 31, 2010, is \$8,880,444.24.





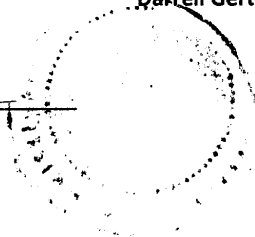
