

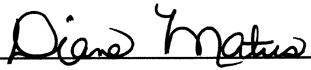

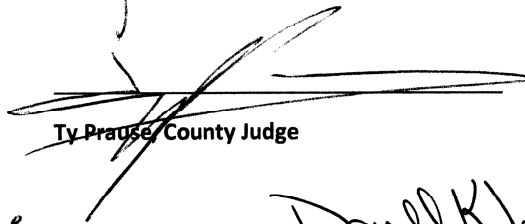

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for June 30, 2011, is \$10,160,120.50.

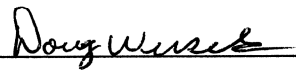
