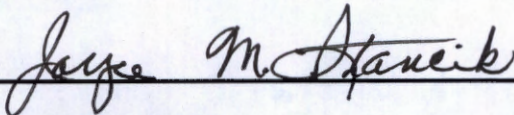

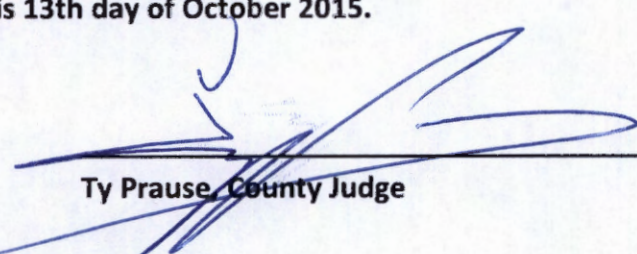

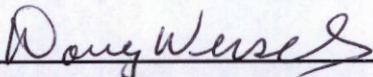
THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for September 30, 2015, \$10,139,251.98.



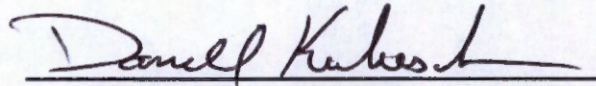
