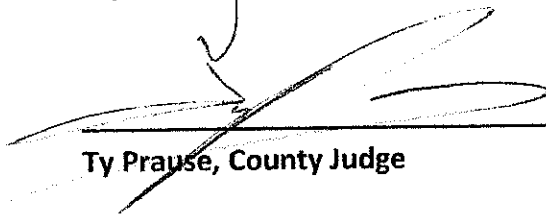

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for January 31, 2015, \$12,290,736.89.

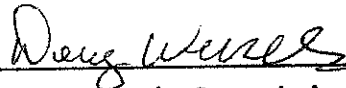

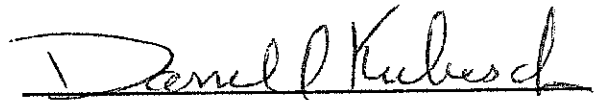

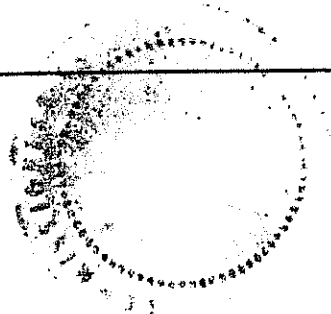
