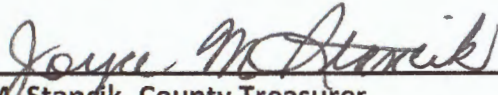

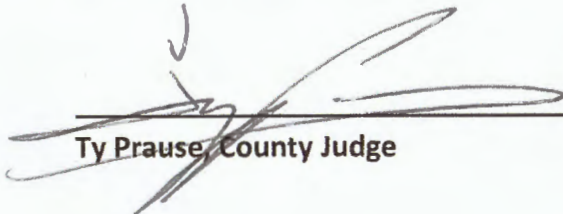

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for May 31, 2013, is \$13,222,439.41.

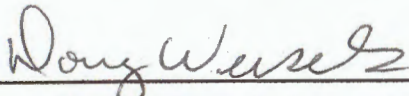
