

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for August 31, 2013, \$11,074,562.05.





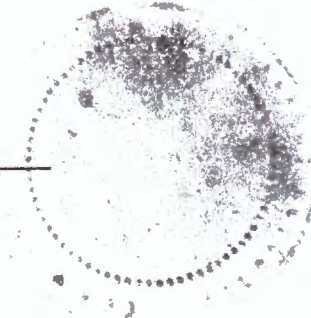
