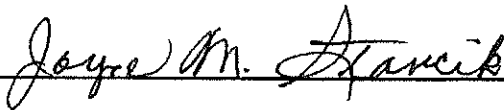

THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for August 31, 2015, \$10,850,073.04.

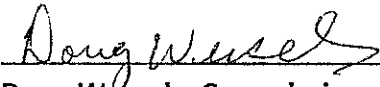
