




THEREFORE, the amount of cash and other assets stated in the County Treasurer's Monthly Report for November 30, 2013, \$9,618,961.49.



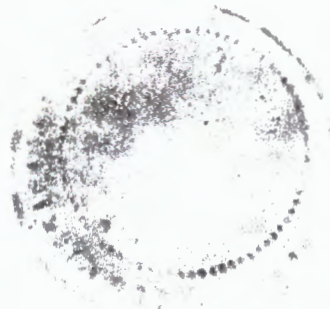
