#### No public comments.

3. Canvass of the November 8, 2022 General Election. (LaCourse)

Rebecka LaCourse, Election Administrator, announced that several poll workers from early voting and central count, and party chairs were present in the courtroom. She recognized their hard work. She reported a total of 7,640 for the General Election. 373 were ballot by mail, 4,462 were early voters, and 2,805 voted on Election Day. She is present today to canvass the official results from November 8 so they may be turned into the State. Judge Prause expressed his thanks to all the volunteers who helped with the election.

Commissioner Kubesch stated he attempted to vote November 4 and was asked to vote electronically, which he refused. He explained he only votes with paper and pencil and had questions as to why the Secretary of State had pulled paper ballots during early voting. Mrs. LaCourse said that because Express Votes were used for early voting, the Secretary of State had her pull paper ballots during early voting per the election code. Commissioner Kubesch also had questions about how emergency paper ballots are created and counted. Mrs. La Course explained that she made copies of the ballots and at the end of the election a resolution board takes the emergency ballots, determines the voter's intent, and recreates the ballots on the Express Votes device. These are then ran through the tabulator. Commissioner Kubesch also asked what happened to the mail in ballots that were not returned. Mrs. LaCourse stated that this happens in most elections and per election code they would be eligible to receive a mail in ballot during the next election as well. He also asked what control she had over poll workers displaying political stickers on their vehicles within a certain distance of the polling place. Mrs. LaCourse said she had no control over that. She referred to an Electioneering law and stated that the electioneering code was changed this year by a Texas Supreme Court Case. If the candidate is not on the ballot, nothing can be said. Commissioner Wessels commended Mrs. LaCourse and all the volunteers on a professional job. Commissioner Kubesch expressed his desire that Mrs. LaCourse, as the Election Administrator, contact Austin and ask that the State have an Election Day versus a week. She encouraged him, in return, to write his Senators and Representatives.




