At which time and place all persons interested in the welfare of PATRICIA TAMEZ are required to appear by filing a written answer, contesting such application.

All interested persons are further advised that they have the right to employ an attorney in this matter. If they or their attorneys fail to file a written notice with the clerk who issued this citation by 10:00 A.M. on the Monday next following the expiration of ten days after the posting of this citation the court may enter orders with binding effects upon said persons.

The officer executing this citation shall post the copy of this citation at the Courthouse door of the County in which this proceeding is pending, or at the place in or near the Courthouse where public notices customarily are posted, for not less than 10 days before the return day thereof, exclusive of the date of posting and shall return the original copy of this citation to the clerk stating in a written return thereon the time when and place where he posted such copy.

You are notified that you have the right under Texas Estates Code Section 1051.252 (Texas Probate Code Section 632(j)) to file with the clerk a written request that you be notified of any or all specifically designated motions, applications, or pleadings filed by any person, or by a person specifically designated in your request, relating to any subsequent guardianship proceeding involving the ward after the guardianship is created, if any. If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the requested notice.
