mentioned time and place by filing a written answer contesting such application should they desire to do so.

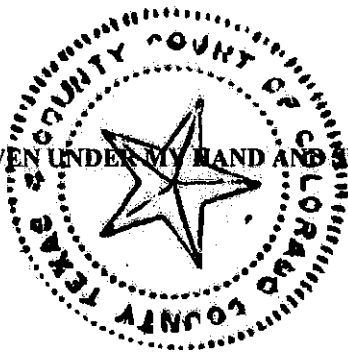
